- g. Championship Advisory Committee Meeting Report Sid McNeil
 - i. The advisory board has recommended the following:
 - Continue the use of competition suite for tabulation purposes and move back to dropbox/usb for judges commentary.

- 2. The purchase of tablets for judges at each site to use in conjunction with competition suite.
- 3. A proposal was passed to add an option to the declaration form that allows the choice between 2 performances or 1 performance for individual classes. When you declare for championships you will mark on your form whether or not you are in favor of prelims/finals or just finals. This will be determined on a class by class basis with the majority of qualified bands deciding.
 - a. Example in class 3A there are 9 bands qualified, and six vote for finals only/one performance. Then there will only be one performance in class 3A. However, if the majority of class 4A votes for two performances, then class 4A will have a prelims and finals.
 - b. If approved by the MHSAA, this will go into effect for net year.
 - c. Reason this could lead to a shortened day for all involved.
- 4. With Pearl moving to class 6A we are having to look at site assignments and dates. There is a possibility we may have to return to two sites and this could also force us to put different classes on different weekends. We very well might have to use the ACT weekend for a classification. We are early in our planning stages for redoing this, please know that in order to keep the safety of

the students a priority, we feel like the current schedule must be shortened. This was the consensus of the advisory board. We will have concrete answers by the end of this school year. Prepare for either the 4th or 5th weekend for next year.
